Spain • The pace of job creation eases in August

Data

- The **number of social security affiliates** decreased by 14,976 in August, in seasonally adjusted terms. The total number of affiliates stood at 18,309,844.
- **Registered unemployment** grew by 11,437 in August, also in seasonally adjusted terms. The total number of unemployed stood at 3,382,324.

Assessment

- The good pace of employment creation in August, at 3.4% year-on-year, confirms a buoyant labour market, despite standing somewhat short of CaixaBank Research's forecasts.
- As usual in the month of August, **the number of social security affiliates declined** (–179,000, not seasonally adjusted), with the mentioned dip being concentrated in education (–60,004), the manufacturing industry (–21,424) and construction (–19,701). In year-on-year terms, however, the number of affiliates increased by more than 600,000.
- Registered unemployment increased by 46,400 individuals (not seasonally adjusted), representing a larger uptick than anticipated. Nonetheless, registered unemployment continued to decline at a rapid pace (-8.5% YoY).
- In the light of these figures, the risks for the full-year affiliate growth forecast of 3.5% are slightly downward biased.




Affiliated to the Social Security*
