- As expected, the Governing Council of the ECB did not introduce changes in its monetary policy stance and maintained its pledge to move slowly in removing stimulus, repeating that interest rates are expected to remain at present levels until well past the end of net asset purchases.
- ▶ During the press conference that followed the meeting, Draghi commented on the U.S. Treasury Secretary remarks in favor of a weaker dollar, saying such comments may violate agreements to avoid competitive currency devaluation and that part of the euro's strength was due to the region's improving outlook.
- In FX markets, the euro closed the day relatively unchanged after reaching 1.25 dollars just after Draghi's press conference. Later, the declarations of Trump in favor of a strong dollar contributed to an appreciation of the greenback.


