- Investors started the week with a negative mood as the U.S. is scheduled to impose tariffs on \$34 billion of Chinese goods on Friday. In stock markets, European and emerging economy indices suffered a broad-based decline, while U.S. stocks reversed early-trading losses and ended the session with moderate gains.
- In fixed-income markets, yields on sovereign bonds nudged up in the U.S. and edged down in Europe.
- This morning, Asian stocks traded mixed and China's currency weakened against the USD. The PBOC issued a statement reminding investors of China's willingness to keep a stable yuan under the current FX mechanism.
- In the U.S., soft indicators continue to point to a strong pace of growth and June's ISM Manufacturing index edged up to 60.2 points (May: 58.7).
- In the euro area, the unemployment rate stood at 8.4% in May, stable compared with April 2018 and down from 9.2% in May 2017. This remains the lowest rate recorded since December 2008.


Yield on 10-year public debt: U.S. and Germany




Exchange rate: EUR/USD
